In supersession of Health & Family Welfare Department Resolution No. 29940/H., Dated. 29.12.2009, Government have been pleased to enhance the existing consolidated monthly remuneration of the doctors engaged on contractual basis against the vacant posts of Assistant Surgeons/Specialists in different Health institutions of the state in accordance with the guidelines issued vide Health & Family Welfare Department Resolution No-20245/H., Dated.07.08.2007. The details of the consolidated remuneration so revised are given below:

1. The contractual doctors posted against the vacant post of Asst. Surgeons/ Specialists are to be designated as "Consultant Physician" / "Consultant Specialists".
2. The Contractual doctors shall only be posted against corresponding sanctioned vacant posts.
3. The Rogi Kalyan Samiti (RKS) of the hospital concerned will monitor the attendance and performance of such contractual doctors. The appropriate Govt. Authority only on receipt of the certificate from the Member Secretary of Rogi Kalyan Samiti regarding attendance and performance of the doctors of the respective hospital will disburse the remuneration to the contractual doctors (herein after called as Consultant Physician or Consultant Specialist).
4. Attendance and Performance Certificate given by the Member Secretary of the concerned Rogi Kalyan Samiti will be placed in the Governing Body of the Rogi Kalyan Samiti.

This will come into effect from the date of the issue of the Resolution.
